

Moore Community House, Inc. Women in Construction Program Built to Win Raffle 2025

Official Terms and Conditions

The Built to Win Raffle 2025 ("Raffle") is conducted by **Moore Community House, Inc.**, a nonprofit organization located in Biloxi, Mississippi. Proceeds from this Raffle directly support Moore Community House's *Women in Construction* program, which provides free workforce training for women pursuing/entering skilled trades careers.

1. Eligibility

- i. Must be 18 years of age or older at the time of ticket purchase.
- ii. Must be the home/property owner where prize will be delivered or obtain written permission from home/property owner. Moore Community House is not responsible and will not be held liable for placement of shed and will not relocate shed once delivered, if proper permissions and/or permits were not obtained.
- iii. Moore Community House employees, employees' spouses, board members, board members' spouses, and any members and spouses of members of any governing body of Moore Community House are not eligible to participate.

2. Tickets

- i. One ticket represents one entry into the raffle drawing. An entry represents a chance to win the opportunity to accept an offer of the stated prize as per the terms and conditions set forth herein and in the Winner Notification Agreement.
- ii. Tickets are available for purchase beginning October 4, 2025 at 8:00 AM (CST) through December 4, 2025 at 11:55 PM (CST).
- iii. Tickets may only be purchased through authorized Moore Community House representatives or approved online platforms.
- iv. Ticket price is \$20 each, or 6 tickets for \$100.
- v. The \$20 entry price, payable to Moore Community House, Inc., is not deductible for federal income tax purposes.
- vi. All ticket sales are final. No refunds will be issued.

3. Prize

- i. One (1) prize will be awarded: a custom-built 8'x6' shed, with unfinished exterior wood constructed by participants of Moore Community House's *Women in Construction* preapprenticeship program.
- ii. Approximate retail value: \$3,000.
- iii. The prize is awarded as-is, with no express or implied warranties.
- iv. Moore Community House will provide delivery of shed within 30-mile radius of the Women in Construction address: 684 Walker Street, Biloxi, MS, 39530.
- v. Winner is responsible for all costs related to installation, site preparation, and/or permits.

vi. No cash alternative or prize substitution is permitted.

4. Drawing and Winner Notification

- i. The drawing will be held on **December 5, 2025 at 1:00 PM (CST)** at the Women in Construction training facility and will be shared via Facebook Live.
- ii. Winner will be selected at random from all eligible entries.
- iii. Winner need not be present to win.
- iv. The winner will be notified by phone and email within 72 hours of the drawing. If the winner cannot be contacted or does not claim the prize within **10 calendar days**, Moore Community House reserves the right to select an alternate winner.
- v. Winner must take possession of prize within 60 days of notification or prize will be forfeited and an alternate winner will be chosen.
- vi. Winner will be required to sign a Winner Notification Agreement to receive prize.

5. Taxes and Reporting

- i. Due to the raffle ticket price of \$20 and a Fair Market Value (FMV) of the prize at \$3,000, Moore Community House is not required to file Form W-2G with the IRS.
- ii. Winner should contact a professional accountant for tax and reporting requirements.

6. Publicity Release

i. By accepting the prize, the winner agrees to allow Moore Community House to use their name, likeness, and statements for promotional and fundraising purposes, without additional compensation, unless prohibited by law.

7. General Conditions

- i. Moore Community House reserves the right to cancel, suspend, or modify the Raffle if any fraud, technical failure, or other factor impairs the integrity of the Raffle.
- ii. By participating, entrants agree to be bound by these Terms and Conditions and by the decisions of Moore Community House, which shall be final and binding.
- iii. Moore Community House shall not be responsible for lost, late, misdirected, incomplete, or ineligible entries, or for any technical issues that may affect participation.

8. Governing Law

i. Void where prohibited by law.
